6. **Methods for exercising rights** : Warrant holders can request a form of intent to exercise their rights to purchase ordinary shares at the Company's office or can be downloaded from the Company's website <https://www.bwg.co.th> during the period of notification of intent to exercise the right or the period for notifying the intention to exercise the last right.
In the event that the warrants are in the Scripless System, the



warrant holders who wish to exercise their rights must notify their intention and complete the request form for the withdrawal of the warrants or for the issuance of warrants or warrants substitutes rights as specified by the SET by submitting to the securities company that acts as their brokerage (Broker) and such securities companies will notify the Securities Depository to request for the withdrawal of the warrants or for the issuance of the warrants or substitutes for the warrants for use as evidence supporting the exercise of the rights to purchase ordinary shares to be submitted to the Company to continue to exercise the rights stated above.

However, if the Warrant Holder does not deliver the evidence supporting the exercise as mentioned above, the Company will assume that the warrant holder does not wish to exercise the right under the warrant at that time. - (b) Payment by cheque, cashier's cheque, draft, bank note, or bank order, the check must be dated 2 days prior to the exercise date and can be collected in Bangkok. within each exercise date by crossing payable to " Better World Green Public Company Limited." and attaching evidence of payment before on February 11, 2026, at 11:00 a.m. However, the exercise of rights to purchase such ordinary shares will be valid only after the Company has been able to collect the said amount. If you can't charge for any reason that are not caused by the Company, it shall be deemed that the warrant holder intends to cancel the exercise of such right and the Company agrees to be considered a termination of the request to exercise the right at that time. However, this does not deprive the warrant holders of their rights to exercise their rights to purchase ordinary shares in the next time except for the cancellation of the last exercise of rights, it shall be deemed that the right to purchase the ordinary shares under such warrants shall no longer be exercised.
